From EMS first responders to inpatient care teams, this course will highlight the vital role each member plays in providing state of the art stroke care to the patients of our community.

Teaching methods include lectures, case presentation, panel discussion, simulation and patient experience.

TARGET AUDIENCE: This course is appropriate for physicians, residents, and advanced practice providers who specialize in emergency medicine, hospital medicine, internal medicine, neuro-critical care, neurology and radiology. This course will also be of interest to nurses and emergency medical service providers including EMTs, firefighters and paramedics.

 of treatment from EMS to the ED to definitive care
- Assess opportunities for collaboration with other healthcare providers to improve care of patients in your community
